

## **Terms and Conditions**

### **1. Organiser**

The Organiser of this contest is the British Council Montenegro. The Organiser reserves the right to terminate or modify any part of the terms and conditions. ### **2. Eligibility and duration**

The contest is open to all English teachers in Primary and Secondary schools in the Republic of Montenegro. The contest will start at 12h (noon) on 03 February 2015 and will end at 12h (midnight) on 08 March 2015. ### **4. Prize**
